

# Innovatus Imaging Europe B.V. Privacy Statement

## 1. Privacy policy

Innovatus Imaging Europe B.V. is engaged in providing service and performing repairs of the radiological devices that enable unprecedented precision in imaging. Privacy information is processed within the company, also known as personal data. In many cases, there is collaboration with other organizations. Respect for the privacy of (potential) clients is an important starting point in this respect. Innovatus Imaging Europe B.V. will only process personal data in accordance with a strict privacy policy and in accordance with the applicable privacy regulations.

In this privacy statement, Innovatus Imaging Europe B.V. has put in a row for you how it is dealing with personal data. That means, for example, that we:

- clearly state for what purposes we process personal data;
- limit the collection of personal data to data that are necessary and proportionate for the purposes described;
- first ask you for express permission to process your personal data in cases where this permission is required;
- not pass your data to third parties, unless this is necessary to deliver the agreed service or when we are legally obliged to do so;
- when we share your data, we make arrangements to ensure that this information is not used for other purposes;
- take appropriate security measures to protect your personal data and also require the parties that process your personal data in our order;
- respect your right to provide, correct or delete your personal data on request;

## 2. Use of personal data

Depending on the goods and services that Innovatus Imaging Europe B.V. the following personal data can be processed for you or provided for you:

- Name and contact details of customers;

Your personal data is usually provided to us by yourself.

## 3. Purposes

Innovatus Imaging Europe B.V. will use the personal data provided by you for the delivery of the products or services ordered by you, as well as for compliance with legal obligations.

## 4. Apply for a job at Innovatus Imaging Europe B.V.

If you have applied for a job with us, but you have not been accepted, all application data will be saved for up to 4 weeks after the end of the application procedure. Only if you have given us permission for this Innovatus Imaging Europe B.V. can keep this data for up to a year.



## 5. Provision to third parties

Innovatus Imaging Europe B.V. can pass your personal data to third parties. This is how Innovatus Imaging Europe B.V. use of third-party software for administration and execution of orders, relationship management and ICT support. This use is limited to these purposes.

When we provide your data to third parties, we determine that these data may only be used for a specific designated purpose. Furthermore, we require that this data is appropriately secured and removed at our first request. Apart from that, we will only pass your details to third parties if we are legally obliged to do so.

## 6. Security and storage

Innovatus Imaging Europe B.V. takes appropriate security measures to prevent misuse of and unauthorized access to your personal data. Security and security measures will be regularly monitored and, if necessary, adjusted. If necessary, we will encrypt the data and log the access. We do not store your data longer than necessary. Except the data that we have to keep for a longer period in order to comply with statutory data retention or for legitimate interest.

## 7. Rights

Requests regarding the right to provide, correct or delete your own personal data on request can be notified via the email address mentioned in "10 Contact us". We aim to process requests within 1 month. Furthermore, Innovatus Imaging Europe B.V. will offer you for all registrations on the basis of permission an unambiguous so-called Opt-out procedure.

## 8. Authority personal data

Of course we are happy to help you with complaints about the processing of personal data. Should you nevertheless not come together with us, then you also have the right under the privacy legislation to file a complaint with the privacy regulator, the Authority Personal Data (for more information see [www.autoriteitpersoonsgegevens.nl](http://www.autoriteitpersoonsgegevens.nl)).
